1. Georgia has received financing from the Asian Development Bank (ADB) toward the cost of **Urban Services Improvement Investment Program - Tranche 6**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The **United Water Supply Company of Georgia LLC (UWSCG)** ("the Employer") invites sealed bids from eligible bidders for the *Construction of Wastewater Treatment Plant in Marneuli.* The Facility is located in the town of Marneuli, which is situated in Georgia's southeastern part of the Kvemo Kartli region, approximately 39 km in the south of Tbilisi.

The short description of works is as following:

Design, construction and commissioning of a wastewater treatment plant (WWTP) for Marneuli. The design is to cater for the full flow and pollution loads for the 2044 population equivalent (PE) of 59,015. The plant shall consist of pumping stations, screens, aeration and sedimentation tanks, operation and administrative buildings, sludge thickener, etc. The construction period is 540 days (including period of commissioning, training and operational acceptance).

3. **International Competitive Bidding** will be conducted in accordance with ADB's <u>Single-Stage: One-Envelope</u> bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Document.

- 4. The minimum key qualification criteria include, but are not limited to the following:
 - Average Annual Construction Turnover: Minimum average annual turnover of USD 15 million or equivalent calculated as total certified payments received for contracts in progress or completed, within the last 3 years (in case of Joint Venture: Each partner must meet 25% and One partner - 40% of the requirement);
 - Financial Resources: The Bidder must demonstrate access to, or availability of liquid assets, lines of credit, or other financial resources, to meet the Bidder's financial resources requirements in the amount of USD 1.85 million or equivalent (in case of

Joint Venture: Each partner must meet 25 % and One partner - 40% of the requirement); and

- Contract of Similar Size and Nature: Participation as contractor, management contractor, or subcontractor, in at least one (1) design and build contract that has been successfully or substantially completed within the last 5 years and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 8.9 million or equivalent. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity or other characteristics as described in Section 6, Employer's Requirements of the bidding documents (in case of Joint Venture: One partner must meet the requirement).
