
#### INTRODUCTION

Over the past year 2020, LEPL State Procurement Agency (hereinafter – SPA) had to perform and accomplish particularly complex and responsible tasks requiring both – operating in extraordinary situation, as well as performance of a wide range of assignments and tasks with high professionalism and competence within tight timeframes and with limited resources.


Due to the outbreak of pandemic, over the year 2020 the leading staff of the SPA had to work in completely new and unusual circumstances – having special schedule, overcoming and tackling a multitude of new and unforeseen challenges given a great number of extraordinary assignments set by the government of Georgia taking into account necessity of different mode of coordinated work with the Administration of the Government, Coordination Council and operational headquarters, as well as with the Ministries and other bodies and institutions. These and many other factors conditioned completely different pace and intensity of work of the SPA team.

Current year was intensive in the light of extraordinary and unusual working mode evoked by the pandemic, as well as in terms of resolution of many ongoing and operational tasks; this year stood out for numerous reforms and introduction of new directions.

Regardless the pandemic, positive tendencies were observed in the procurements carried out in the Unified Electronic System Public Procurement. particular, the quantity of awarded tenders increased by 3 percentage points - from 71% to 74%; respectively, the quantity of tenders with no bids received. contracts were not awarded and cancelled tenders amounted to only 26%.




Similar to successful tenders, the index of average number of bidders participating in tenders was increased significantly – from 2.05 to 2.27.





It is noteworthy, that compared to the year 2019, total value of public procurement contracts reduced from 5,332,804,815 to 5,158,143,556. Slight decline in net value of contracts was largely conditioned by the reduction of economic activities in the country caused by the pandemic. The aforementioned amount accounts for 10.4% of GDP of Georgia for 2020.

## Total values of public procurement contracts by years (Billion GEL)






#### 1. KEY DATA INDICATORS OF PUBLIC PROCUREMENT

#### 1.1 QUANTITY AND TYPES OF ANNOUNCED TENDERS

In 2020, in total 25,598 tenders were announced through various electronic procedures<sup>1</sup>. As Diagram N1 shows, most frequently contracting authorities were applying NAT and SPA types of open, electronic procedures. For comparison, total of 34,216 different types of electronic procurement procedures were announced in 2019. Respectively, total amount of electronic procurement announced in 2020 reduced by approximately 25% as compared to the previous year. Significant decline in the amount of announced tenders was largely entailed by the reduction of economic activities in the country caused by the pandemic.

Diagrams N2 and N3 below clearly show that the number of tenders were reduced in the second quarter the most and this reduced activity continued till the end of the year.

Diagram N2: Distribution of tenders announced in 2020 according to months






Diagram N3: Distribution of tenders announced in 2019 according to months






# 1.2 VALUE OF PUBLIC PROCUREMENT CONTRACTS AND STATUSES OF TENDERS

Similar to the number of announced tenders, we also observe the decline in the number of tenders which were completed and to which final statuses were assigned in 2020. The number of such tenders amounted to 25,019, which is 7,552 tenders less than similar number for 2019. Furthermore, compared to the similar figures for the previous year, the share of successful tenders increased by 3% and totaled 74%; respectively, the share of the tenders with the statuses – "Cancelled", "Contract Not Awarded" and "No Bids Received" amounted to 26%. Diagrams N4, N5 and Table N1 below give detailed information about the distribution of final statuses of completed tenders, as well as about top 20 contracting authorities, which contributed to the highest proportion of successful tenders.

Diagram N5: Distribution of contracts awarded in 2020 according to the objects of procurement






Total volume of public procurement carried out in 2020 amounted to 5,158,143,556 GEL which

accounts for 10.4% of the country's GDP<sup>4</sup>. Net contract value of public procurement awarded on the bases of electronic tenders and consolidated tenders accounted for 4,088,057,239 GEL<sup>5</sup>, whereas net value of simplified public procurement contracts made 1,070,086,317 GEL (See Diagram N6). It is noteworthy to mention here, that over the half of the value of simplified procurement falls on agricultural subsidies allocated by the state, also on various critical medical equipment and medication procured in the process of management of the pandemic, as well as on public procurements performed by observing the monetary threshold set for simplified procurement (GEL 5,000) (See Diagram N7).





Diagram N7: Simplified procurements




As above Diagrams N6 and N7 depict, if we subtract the contract values of public procurement related to subsidies and pandemic (497,806,678 GEL) from the total volume of simplified procurement (1,070,086,317 GEL), we may consider that the total of 572,279,639 GEL was spent on all types of so-called "conventional" simplified procurement<sup>6</sup>, which, in turn, equals to only 11% of total volume of public procurement (See Diagram N8).

Almost of 84% of the net value of contracts of electronic tenders (3,711,057,239 GEL) falls on large-scale tenders whose contract value exceeded 200,000 GEL, whereas the same tenders accounted for only 14% of all the completed tenders. Thus, contract value of 86% of tenders carried out in 2020 was below 200,000 GEL. See Tables N2, N3 and Diagram N9 below for further details with regard to the aforementioned data.

The number of tenders carried out in 2020 has significantly reduced as compared to 2019. However, the amount of tenders whose contract values exceeded 200,000 GEL has increased slightly (See Table N3 and Diagram N9).



It is noteworthy, that over 88% of the amounts spent on the bases of tenders was distributed over 20 most large-scale CPV categories whose net contract value amounted to 3,276,578,859 GEL. Moreover, the largest amount of the aforementioned large-scale CPV categories – up to 2.9 billion GEL was spent on the infrastructural and construction works of different types of civilian buildings and structures, as well as on the services related to construction works (such as, architectural and engineering services).

#### 1.3. SAVINGS AND NUMBERS OF BIDDERS IN TENDERS

Total difference between the net estimated value of tenders carried out in 2020 and final prices offered by the suppliers amounted to approximately 11%. Hence, savings obtained as a result of competition in tenders and reduction of prices by the suppliers amounted to approximately 417 million GEL. Of them, most savings – up to 323 million GEL was made in tenders announced for the performance of construction works.



As aforementioned tables show, over half of the savings recorded in public tenders, that is 221,179,065 GEL, falls on the tenders announced by the Top 10 contracting authorities.



Contrary to the reduced number of conducted tenders, average index of bidders' participation in tenders increased up to 2.27 in 2020 (similar showing for 2019 amounted to 2.05).

Similar to the previous years, the highest index of average number of bidders, that is 2.9, was recorded in the tenders announced for the CPV categories of construction works; 2- in the tenders announced for the CPV categories of goods and 2.01- in the tenders announced for the CPV categories of services.




Diagram N11: Average number of bidders according to procurement objects12



Similar to the procurement categories and the tenders announced by various contracting authorities, average number of bidders are drastically different according to the types of tenders as well. In particular, average number of bidders in NAT tenders exceed the average number of bidders recorded in SPA tenders by approximately 28% (See Diagram N13).

Diagram N13: Average number of bidders according to types of tender






# 1.4 USERS REGISTERED WITHIN THE SYSTEM AND SUCCESSFUL SUPPLIERS

During the year 2020, 2,652 new suppliers and 75 new contracting authorities registered in the e-Procurement System. Hence, in the end of the year, the number of contracting authorities and suppliers registered in the System amounted to 4,464 and 44,173 respectively, which in total amounts to approximately 25% of active economic entities registered in the country<sup>15</sup>.

Diagram N14: Number of suppliers registered within eProcurement System of Public Procurement according to years





#### 1.4.1 NON-RESIDENT SUPPLIERS

In 2020, 45 procurement contracts were awarded with non-resident suppliers from 18 different countries based on public tenders. Total value of public contracts amounted to 73 million GEL.

The largest proportion of the aforementioned sum, that is contracts with the value of 32 million GEL, were awarded to the companies registered in France. Table N12 below shows the distribution of the values of contracts awarded with non-resident suppliers according to countries.

In addition to the public procurement contracts awarded through the aforementioned tenders, 134 simplified procurement contracts were awarded with non-resident suppliers in 2020. Total value of these contracts accounted for approximately 12 million GEL. In total, starting from 2016 through 2020, various non-resident suppliers were awarded simplified procurement contracts with the value of 97 million EUR through direct contracting.


During 2020, 77 new non-resident companies were registered in the e-Procurement System of and by the end of the year, the number of non-resident companies registered in the System amounted to 2,054. The aforementioned non-resident business entities<sup>16</sup> are representing 75 different countries from around the globe (See detailed information in Diagram N16).

#### 1.5 PROCUREMENT WITH THE DONOR FUNDS – DEP TENDERS

In 2020, procurement contracts were awarded for 26 completed DEP tenders and net contract value accounted for approximately 87 million GEL. Procurement carried out through DEP tenders were funded by the World Bank, European Investment Bank, Nordic Environment Finance Corp., Asian Development Bank and European Union. Table N14 below shows distribution of net contract value of tenders according to donor organizations and international financial institutions.

The largest procurement carried out through DEP tender was performed by the Georgian State Electro System; the procurement was funded by the World Bank. Contract value of the mentioned DEP tender<sup>17</sup> amounted to 51,778,023 GEL. #### 2. IMPROVEMENTS TO LEGAL FRAMEWORK

Over 2020, the State Procurement Agency prepared and issued, under the established procedure, a number of legal acts, in particular:

The State Procurement Agency, as a result of coordinated work with the Administration of the Government of Georgia, Georgian National Competition Agency, Ministry of Finance of Georgia and Parliamentary Budget Office of Georgia, drafted the Law of Georgia No6730 on Amendments to the Law of Georgia on Public Procurement adopted by the Parliament of Georgia on 2 July, 2020 (which envisages approximation with numerous components of the Directives referred to in the Association Agreement between the EU and Georgia and applied in the field of public procurement [2014/24/EU; 89/665/EEC], as well as their implementation in the national legislation).

In view of the fact that, under the aforementioned law, institutionally independent new Dispute Resolution Council was set up and new regulations were determined for appealing a number of public procurement-related decisions, it was necessary to draft the legal act regulating activities and operation of the aforementioned Council. This was also implemented by the Agency. Furthermore, necessary draft amendments entailed by the aforementioned law were elaborated. The draft amendments were reflected in the respective subordinate normative acts of the Chairperson of the State Procurement Agency.

According to the amendments, the Council set up for reviewing public procurement-related disputes or the Court will be authorized to review the disputes related to public procurement. The law no longer provides for a contracting authority as one of the bodies authorized to review disputes (by way of administrative proceedings), since this is related to a number of practical challenges; in particular, according to the General Administrative Code of Georgia, administrative appeal shall be reviewed by a superior official or a superior administrative body. Due to the fact that public procurement is carried out by tender/competition committees, this renders it impossible for a superior official or body to unilaterally examine and review collegial decisions made by tender/competition committees on the bases of an administrative appeal.

In addition to the aforementioned, as a result of amendments, the Council does not have two compositions any longer, it has only one composition comprised of 5 members. Qualification requirements similar to those set for the judges of Common Courts were determined for the membership of the Council with slight differences.

Moreover, the amendments increased the list of disputable issues subject to being appealed to the Council; in particular, decisions related to the award of simplified procurement contracts will also be appealed to the Council where the estimated value of goods, services or works to be procured equals to or exceeds the monetary thresholds established by the EU Directives in the field of public procurement. Furthermore, it was established that the decisions related to the award of simplified procurement contract will not be appealed below the EU monetary thresholds. In addition, it was defined that in case of appeal, so-called "standstill" mechanism will apply during which public procurement procedures will be suspended, however, simplified procurement procedure brought about by the extreme urgency will not be subject to suspension due to its substance.



In addition to the abovementioned, amendments were made to the procedure for seeking the approval of the Agency for carrying out public procurement through simplified procurement upon extreme urgency. According to the amendment, in case of extreme urgency, the procurement procedure to be carried out on the grounds of extreme urgency shall be approved by the Agency only in case the value of goods, services or works is below the monetary thresholds established by the EU Directives in the field of public procurement.

The implemented amendment allowed the Council to prolong the timeframe for making the decision by not more than 10 working days which is caused by several factors, inter alia, it is conditioned by the fact that the list of issues subject to being appealed has increased, whereas the Council has become a specialized body whose members can no longer carry out other part-time paid activities.

The aforementioned legislative amendment led to amendments to a number of subordinate normative acts adopted by the Chairperson of the State Procurement Agency. With a view of executing the abovementioned legislative requirement, significant amendments were made to the Order No13 of the Chairperson of the State Procurement Agency, dated 17 August, 2015, on "Defining the Criteria for Simplified Procurement and Approval of the Procedure for Carrying out Simplified Procurement" and a number of commitments and obligations to be performed by the contracting authorities were determined; among them, the following were defined:

- Where the value of simplified procurement equals or exceeds the monetary thresholds established by the EU Directives in the field of public procurement, a contracting authority shall be obliged to publish the decision on awarding a simplified procurement contract on the SMP module of the System in accordance with the Annex to the abovementioned Order;
- A contracting authority shall be obliged not to award a simplified procurement contract
  within 10 calendar days following the publication of the decision on awarding a simplified
  procurement contract on the SMP module of the System (except for the cases of extreme
  urgency);
- Where a decision on awarding a simplified procurement contract is appealed to the public
  procurement-related Dispute Resolution Council and the Council grants the submitted
  appeal fully or partially, a contracting authority shall be obliged to review or annul the
  decision on awarding a simplified procurement contract within reasonable timeframes
  following the respective decision of the Council, in compliance with the decision of the
  Council;

Moreover, during the year 2020, the Agency, together with European experts (EU-funded Twinning Project "Strengthening Public Procurement Practices in Georgia"), continued working on the draft Law of Georgia on Public Procurement, on fine-tuning the draft Law and working on subordinate normative acts deriving from the aforementioned draft Law. The activities were implemented in on-line mode. The Agency is also cooperating with legal entity under public law of the Ministry of Environmental Protection and Agriculture of Georgia - Environmental Information and Education Centre (EIEC) and United Nations Environment Programme (UNEP) within the frames of the project, as a result of which respective norms related to the concept of Sustainable Public Procurement (SPP) were reflected in the draft Law of Georgia on Public



Procurement. Within the frames of the above-mentioned project, cooperation also continues in the light of drafting subordinate normative acts regulating Sustainable Public Procurement, as well as in the light of preparing and drafting respective materials and guidelines of advisory nature. Work is also underway on the selection and analysis of the commodity nomenclature given under the mentioned concept (among them, CPV codes in accordance with the UNEP international methodology).


Hence, as a result of the implemented reforms, national legislation in the field of public procurement approximated respective EU Directives and regulations even more.



#### 3. PUBLIC PROCUREMENT RELATED DISPUTES

Over the year 2020, 1,044 complaints were filed to the Dispute Resolution Council set up on the bases of the Law of Georgia on Public Procurement, which is 201 complaints less as compared to the previous year. Majority of the complaints filed in 2020 - 559 complaints in total, were adjudicated in favor of business (partially or fully granted by the Council), which made 54% of total number of submitted complaints. This fact verifies the impartiality of the Dispute Resolution Council, as well as high level of trust of business to the Council.


Diagram N17: Statistics of complaints filed with the public procurement-related Dispute Resolution Council in 2011-2020

Among the claims submitted to the Council in 2020, most of the claims relate to annulment of the decision/action of a contracting authority irrelevant to the legislation. Most of 1,044 filed complaints, i.e. 848 complaints concerned the decisions and actions of tender/competition committees, whereas 196 complaints applied to tender terms and conditions (See Diagram N19).

Diagram N19: Grounds of complaints filed with the public procurement-related Dispute Resolution Council in 2020



In 2020, net initial estimated value of procurement carried out through consolidated tenders amounted to 394 million GEL, of which final value recorded in e-tendering equaled 377 million GEL; respectively, savings through e-tendering amounted to approximately 17 million GEL. It should be mentioned here, that there are frequent cases when minimal prices are recorded as initial estimated prices in consolidated tenders as a result of efficient market research and consultations carried out by the SPA; due to this, savings through e-tendering are reduced. In such cases, the figures of savings through only e-tendering do not give an impartial picture in order to demonstrate efficiency of centralized procurements. Due to the foregoing, it is expedient to consider retail and market prices as well in order to evaluate centralized procurement reform objectively (See Table N18).

Prior to announcing the aforementioned tenders, market research of respective field was carried out and draft tender documentations were drawn up. Furthermore, business meetings were held with the experts of respective fields with the aim to bring the procurement objects announced within the frames of consolidated tenders into line with international standards, as well as to draft technical specifications taking into account of market opportunities.



It is noteworthy, that several new procurement objects were centralized for the first time in 2020, among them, textbooks, waste containers, some of school furniture and equipment. Moreover, with the view of cost-effective use of public funds and prompt mobilization of respective products for state organizations, a number of tenders were announced for the goods necessary to fight against pandemic, in particular: tenders for face masks, disinfection barriers, disinfectant liquid (intended for hands and disinfection barriers) and electronic thermometers (see Table N19). As a result of announcing tenders for these new procurement objects, we can observe reasonable savings of public funds and more access for bidders to open tenders, as well as reasonable improvement of quality of procurement objects, their standardization and unification.

In 2020, over 5,000 fuel and paper authorizations, filed by contracting authorities in a specialized Fuel and Printing Paper module of consolidated tender management system - ctd.spa.ge, were addressed and reviewed with due consideration of developed regulations and guidelines and relevant statuses were awarded to each authorization.

Currently, intensive analytical and research activities are underway in the Agency in order to identify other, additional procurement objects for centralized procurement, which would be justified, taking account of the principle of cost-effective use of public funds.



#### 5. SIMPLIFIED PROCUREMENT

Georgia launched preparation to fight against Coronavirus as far back as in January 2020; in particular, Ordinance No164 of the Government of Georgia, dated 28 January, 2020 approved the "Emergency Response Plan for the Cases of Novel Coronavirus Disease". The aforementioned act of the government of Georgia determined that the procurement of services/goods necessary to ensure the measures specified in the Ordinance was to be performed by the contracting authorities in the case of extreme urgency and/or through simplified procurement in accordance with Article 101(3)(d) of the Law of Georgia on Public Procurement (unimpeded conduct of an event of state and public importance within tight time limits).

Bearing in mind, that epidemiological situation required prompt response and it was impossible to carry out procurements necessary for peoples' life and health applying the timeframes established for electronic tender procedures, contracting authorities, within the frames of the aforementioned authority, carried out public procurement necessary for the prevention of pandemic and its elimination through simplified procurement. It is noteworthy, that the Guidance published by the European Commission (2020/C108I/101) on "Using the Public Procurement Framework in the Emergency Situation Related to the COVID-19 Crisis" explicitly indicates that EU-member states should award respective contracts using the Negotiated Procedure without Prior Publication which, in its substance, is the same as the simplified procurement procedure determined by the legislation of Georgia.

Later on, due to deterioration of epidemiological situation in autumn, 2020, the list of the procurement objects to be procured in the case of extreme urgency referred to in the Annex to the Ordinance No164 of the Government of Georgia, dated 28 January, 2020 and/or through simplified procurement in accordance with Article 101(3)(d) of the Law of Georgia on Public Procurement, was further expanded.

Furthermore, Article 18(10) of the Isolation and Quarantine Rules approved by the Ordinance No322 of the Government of Georgia, dated May 23, 2020 defined that in order to enforce the measures determined by the Ordinance (medical assistance), contracting authorities shall be given the right to procure necessary services/goods in the case of extreme urgency and/or in accordance with Article 101(3)(d) of the Law of Georgia on Public Procurement, under the simplified procurement procedure, with the consent of the State Procurement Agency.

In 2020, the volume of contracts awarded on the grounds of simplified procurement amounted to 21% of the total procurement value, which exceeds similar data for 2019 by 3%. Total of 5,756 applications were received in the SPA in 2020; in 5,222 cases approval was granted, while the number of withdrawn, rejected or unconsidered applications amounted to 534. Diagrams N20 and N21 below show statistics according to the grounds and statuses of simplified procurements.



# Diagram N20: Distribution of applications filed with SMP module of the eProcurement System according to their grounds







Diagram N21: Distribution of applications filed with SMP module of the eProcurement System according to their statuses

# 6. ADMINISTRATIVE INFRINGEMENTS AND COURT LITIGATIONS

In 2020, having examined 30 official notes drawn up with regard to the facts of offences, the SPA, within the scope of the powers granted to it, carried out classification of activities referred to in the official notes in compliance with the respective articles of the Administrative Offences Code of Georgia and written notices were submitted to respective contracting authorities. As a result of review and examination, 30 reports on offences were drawn up and submitted to court against 87 various officials. The court has applied warnings with regard to 86 persons, court hearing is underway against 1 person.

Total of 501 court proceedings were held with the engagement of the SPA in 2020. The SPA prepared 24 private complaints which are under consideration at the moment. 16 complaints were filed with the Panel of Civil Cases with regard to the reimbursement of 1% guarantee; furthermore, 16 private complaints were submitted regarding the same issue. 7 complaints were filed with regard to the reimbursement of 1% guarantee which were appealed by way of administrative proceedings (according to jurisdiction); one of the cases was resolved in favor of the Agency, whereas court proceedings regarding 5 cases are still under consideration. Moreover, the issue was raised with regard to exemption of the Agency from paying state fees which was satisfied by the City Court and the Agency was exempted from paying state fees.


It is noteworthy, that 96 ordinances were appealed in court with regard to the Black List. All the appeals were resolved in favor of the Agency. In addition, 130 notifications were submitted to the court in respect of entry into legal force of ongoing cases. Based on received responses, the companies were registered in the Black List with the remaining period. Furthermore, 19 decisions of the Dispute Resolution Council were appealed, of which the court partially satisfied the request with regard to only one case. Moreover, 6 consolidated tenders were appealed and they are under consideration. Besides, 1 ordinance was appealed with regard to registration in the White List and the case was resolved in favor of the Agency. It is noteworthy, that 3 decisions were appealed in respect of the simplified permission granted through the SMP module which was terminated on the bases of the petition of the Agency. Moreover, the Appeal Court satisfied 4 private appeals submitted by the Agency, as well as 5 statements of defense. 3 cassation appeals have been submitted to court with regard to which no ruling has been made at this point.



#### 7. MAINTENANCE OF THE WHITE LIST

In 2020, total number of decisions on registering economic operators in the register of qualified suppliers participating in procurements - the so-called "White List", amounted to 181. In total, 138 decisions were made by the SPA with regard to registration in the White List and extension of the registration, 15 economic operators were refused to be whitelisted, while 28 cases were unconsidered. The detailed results are shown in Diagram N22.

Diagram N22: Distribution of decisions made in 2020 with regard to registration in the White List, according to their statuses






#### 8. MAINTENANCE OF THE BLACK LIST

In compliance with current legislation, the State Procurement Agency also maintains the register of dishonest suppliers - the so-called Black List.

In total, 598 applications were filed to the SPA regarding registration of suppliers in the Black List. In 434 cases the suppliers were registered in the Black List by the SPA, 113 suppliers were given the warning. The detailed results of the decisions are given in Diagram N23.

#### 9. MONITORING OF PUBLIC PROCUREMENT PROCEDURES

In order to establish compliance of the public procurement procedures carried out by the contracting authorities with the current legislation, during 2020, based on automated system of messaging and via risk methodology system, monitoring department monitored 11,841 e-tenders with status of "contract awarded" (13,414 in 2019) and 1,060 e-tenders with status of "terminated", "failed" and "not awarded" (1,678 in 2019).

Furthermore, 6,494 tenders (8,067 in 2019) were monitored within the System in order to establish the adequacy of exclusion of bidders immediately upon recording the exclusion on the System; in particular, monitoring was carried out whether the exclusion grounds referred to in the System complied with the decision made by the respective minutes, in order to avoid accidental submission of notification by the e-Procurement System with regard to deduction or reimbursement of bidder's guarantee amount. Moreover, the issue of compliance of termination of tenders was verified, in particular, the fact whether the circumstances conditioning the termination of the given tender were reflected in a corresponding manner or not.

In addition to the aforementioned, the SPA carried out the monitoring of 48,319 contracts uploaded in the CMR module of the e-Procurement System (74,307 in 2019), as well as monitoring of 42 announced contests (70 in 2019).

Based on the findings of the monitoring process, 1,593 letters were submitted to contracting authorities with regard to revealed violations. In respect of public procurement carried out by 28 contracting authorities, in which administrative offences provided for by the Administrative Offences Code of Georgia were identified, appropriate official notes were prepared in order to further proceed with the case under the procedure prescribed by the legislation, whereas in other cases the SPA limited itself to written recommendations.

In order to implement the monitoring process in an efficient manner, amendments were prepared to the automated system of messaging of risk factors, in particular, new risk factors were added to the group of risk factors; besides, criteria within it were duly adjusted.



#### 10. DIDACTIC ACTIVITIES

Taking into account extraordinary situation caused by the outbreak of pandemic, the SPA Training Center identified several target groups that needed specialized trainings. Respectively, in addition to the basic training course, additional trainings in three different programmes were rendered in the SPA Training Center in 2020:

- "Public Procurement Course in TV School";
- "Specialized Public Procurement Course for the Prosecutor's Office of Georgia";
- "Remote Training Course of Public Procurement".

In total, 378 trainees were retrained in 2020, in particular:

- From January 20 through January 31, the SPA Training Center retrained 39 public procurement specialists within the framework of "Basic Public Procurement Course" and respective certificates of completion were granted to them;
- From June 22 through July 3, the Training Center implemented TV educational project "Public Procurement Course in TV School" under the assistance of the Georgian Public Broadcaster. Thousands of users, procurers, students and other interested audience listened to and watched the series of TV School programmes; whereas 155 professionally interested viewers registered as active participants.
- From July 14 through July 23, online course "Specialized Public Procurement Course" was rendered to the personnel of the Prosecutor's Office of Georgia. 20 trainees attended each stream of remote learning; in total, 40 trainees were retrained. This new cycle of trainings included 10 thematic classes scheduled in a new manner, while the eleventh session was dedicated to the Q&A;
- In the periods November 16-20, November 24-28, November 30-December 4, December 7-11, December 14-18 and December 21-25, the SPA Training Center delivered the cycle of online trainings "Remote Training Course of Public Procurement" for the public servants employed in state institutions and local self-governing bodies. 24 trainees attended each stream of trainings and in total, 144 specialists were retrained.

Trainings were delivered by the highly qualified trainers of the State Procurement Agency.



#### 11. BUSINESS COMMUNICATION WITH THE CUSTOMERS

In 2020, the document flow (number of incoming and outgoing letters) of the SPA amounted to 12,366 (in 2019 this figure made 14,446). Also 2,457 e-mail letters were received and addressed at the SPA official e-mail (info@procurement.gov.ge). Total 514 letters were archived in 2020 (1,585 in 2019).

Each and every interested person is able to get exhaustive and competent answer via SPA citizen hotline service - +995322484822. In total, 20,637 calls were received and answered by the SPA citizen's hotline service in 2020 (20,298 in 2019).

Short Messaging Service (SMS) and system notices, integrated into the *e-Procurement* System, also the services of web portal – spa.ge, keep persons interested in public procurement constantly updated about the amendments, notices, introduction of new regulations and development of new services. They can also receive timely and exhaustive information about tenders they are interested in. Only in 2020, approximately 40 million system notices and over 206 000 SMSs were circulated.



## 12. INTENSIFICATION OF INTERNATIONAL RELATIONS

The year 2020 turned to be intensive and productive for the State Procurement Agency in the field of international cooperation as well as in terms of public relations. A number of online working meetings, consultations, trainings, seminars and conferences were held, in particular:

- Over 2020, the SPA was periodically reporting on progress of quarterly and annual action plans a on fulfillment of international commitments, inter alia, within the frames of Anti-Corruption Strategy and Action Plan, as well as within the reforms envisaged by the Association Agreement with the EU and DCFTA, OGP, PFM, PAR;
- Over 2020, active cooperation was underway with international organizations within the framework of Public Expenditure and Financial Accountability (PEFA) and OECD Fifth Round of Monitoring of Anti-Corruption Network (ACN);
- With a view of efficient implementation of the components of respective reforms, Deputy Chairperson of the Agency and the heads of relevant departments were actively engaged in the activities of numerous Coordination Councils and Committees set up by the government of Georgia;
- During 2020, the Agency had to cooperate with the EU-funded project, which was underway within the EU Twinning instrument, in a completely new and complicated mode. The Agency had to overcome challenges while conducting negotiations with Austrian and Slovenian partners of the project and European Commission Delegation to Georgia on the one hand, and in the light of engagement of beneficiaries of the project due to complicated coordination, on the other hand. A wide range of activities were held in order to adjust ongoing plans, budget and expected outcomes; study visits and series of conferences/trainings in Tbilisi were cancelled; several large-scale events and conferences were scheduled for February and March, 2021;
- Working on the new draft Law of Georgia on Public Procurement was in progress and completed in 2020; remarks and comments of international organizations (among them, EU Twinning, OECD/SIGMA, UNEP, UN WOMEN, UNECE, UN ILO) and IFI's with regard to the draft Law have already been reflected.
- In the light of legislative approximation with the EU, it is also noteworthy to mention a "Handbook for Members of Procurement Review Tribunals" (Handbook "Key Judicial Skills and Competencies: A Handbook for Members of Procurement Review Tribunals" localized for Georgia), prepared under the assistance of the European Bank for Reconstruction and Development (EBRD). The handbook presents unique source of knowledge and information necessary for the recently selected members of the Dispute Resolution Council, as well as for the staff of the Office and all the other interested or engaged persons.
- On November 24, 2020, a webinar "The Road to GPA Accession" was held. The webinar was organized by the European Bank for Reconstruction and Development and during which, participants discussed readiness of Georgia and other candidate countries for accession to the Agreement on Government Procurement (GPA). During the event, the



participants exchanged information in respect of compatibility with GPA requirements, as well as concerning the challenges associated with it.

- In the light of cooperation with WTO GPA Committee and EBRD, it is noteworthy to mention a completely new diagnostic report developed in 2020 "GPA Compliance Assessment: a review of the public procurement legal framework of selected GPA Observers" final edition of which will be published and disseminated in January, 2021. The report will provide significant assistance to Georgia on the expected complicated path to the accession to relevant structures of the World Trade Organization.
- On November 18, 2020, seminar in a virtual format organized by the WTO GPA was held for new candidates, members of GPA Committee and observers (including Georgia). The meeting aimed at supporting new delegates in order for them to make full use of meetings of the Committee in favor of their countries. During the seminar, the participants got acquainted with the principles of operation of the Committee, as well as practical information regarding documents circulation within the Committee and online means of information. Besides, participants of the meeting got acquainted with the delegates of new member states of the Agreement on Government Procurement.
- The Agency proceeded productive cooperation with the UK-based international organization Open Contracting Partnership (OCP) in 2020 as well. With the support of OCP, the Agency is working on introduction of the world's leading Open Contracting Data Standard (OCDS) to Georgian public procurement system. Data of tenders carried out in 2011-2019 have already been published on a new specialized web page - opendata.spa.ge in the so-called machine readable, JSON format in aggregated manner as well as in the light of separate procurement. Besides, e-Plans of contracting authorities for 2021 are under elaboration and they will be soon published in this new format (data for 2021 of e-Plan module of e-Procurement System in OCDS format). Under the assistance of the World Bank, the Agency has already created a new special visualization web page of OCDS standard - vod.spa.ge; furthermore, activities go on with regard to broader use of Application Programming Interface (API) which will enable all the interested persons to have direct access to all kinds of open data regarding Georgian public procurement. Works in the light of Open Data are coordinated by a recently formed agency of the Ministry of Justice of Georgia - Digital Governance Agency, whereas OGP Georgia Secretariat and PAR Council are actively supporting openness of public procurement data and application of new approaches (Administration of the Government of Georgia is coordinating and facilitating both directions).
- With the engagement of the Ministry of Economy and Sustainable Development and the Ministry of Foreign Affairs of Georgia, the Agency conducted negotiations with the government of the United Kingdom on the Free Trade Agreement. The negotiations addressed changing of monetary thresholds in the Free Trade Agreement which is aligned with the EU monetary thresholds. Annex to the Agreement was updated and it is to be approved by the UK-Georgia Strategic Partnership and Cooperation Forum.



- The SPA goes on productive cooperation with the Commercial Law Development Program (CLDP) of the U.S. Department of Commerce. In February, 2020 a two-day working meeting was held on "Transparent and Efficient Public Procurement". The meeting was attended by the representatives of the Agency and big contracting authorities. Leading experts of the U.S. Department of Commerce were invited to the meeting who provided the participants of the seminar with the information on the best public procurement practices in the USA and Europe.
- In January 2020, in cooperation with Georgia's Innovation and Technology Agency, the SPA conducted an international seminar on Innovations and Sustainability in Public Procurement. The seminar was held under the assistance of the EU Twinning Project. The seminar was attended by the representatives of state agencies, academia, business associations and start-ups. The experts of Austrian Federal Procurement Agency (BBG) were invited to the seminar who provided the participants with the experience of introduction of innovative principles to public procurement.
- Over 2020, the staff of the SPA participated in tens of international seminars which were mostly held in a teleworking mode under the auspices of various international organizations. The representatives of the Agency even acted as keynote speakers at some of these international events (on-line seminars/workshops)
- Starting from September 16 till October 9, 2020, Assessment Mission of EU budget support programme Economic Governance and Fiscal Accountability Programme (EU4EGFA) held online meetings with Georgian government agencies engaged in the Programme. The aim of the meetings was to assess three main directions of the Programme. The SPA is actively engaged in the implementation of the EU4EGFA Programme and the Agency provided the Assessment Mission with the information regarding the progress achieved in fulfilment of assumed commitments.
- On October 7, 2020, WTO GPA Committee meeting was held through an online platform at which the staff of the Agency participated with the status of observers. The issues of entry into force and implementation of an updated WTO GPA was discussed during the meeting.
- On October 19, 2020, online meeting was held with the representatives of the European Commission which was organized by the Ministry of Foreign Affairs of Georgia. The meeting related to drafting a new edition of the Association Agenda for 2021-2027 with regard to which the representatives of the European Commission held presentations.
- On November 3-5, 2020, Asian Development Bank (ADB) organized an annual conference
  of the Asia Pacific Public Electronic Procurement Network. The representatives of the SPA
  participated in the conference which was held through a virtual platform. The participants
  of the conference shared experience of development of electronic public procurement
  network as well as best practices.




- The Administration of the Government of Georgia, in cooperation with the UNDP project "Supporting Public Administration Reform in Georgia" launched drafting a new strategy and action plan for public administration reform; the SPA is actively engaged in the activities. In this respect, an online working meeting was held on December 22, 2020. The meeting was dedicated to the analysis of current situation, as well as identification of major challenges and problems and defining of priorities which will serve as the ground for the new strategy and action plan.
- During 2020, the SPA intensively proceeded cooperation with the EU-funded project underway within the frames of a new regional initiative (EU4Environment) the aim of which is to introduce innovative products and technologies with a view to boosting green investments. One of the components of the abovementioned initiative envisages development of Sustainable Public Procurement (SPP) concept which will serve as an important tool for the development of green economy. Within the frames of the aforementioned project, several drafts of legislative acts were worked out; the process is underway in order to identify the pilot CPV codes to which the Sustainable Public Procurement principles will apply.
