


INTRODUCTION

This present report contains detailed information about the activities implemented by LEPL State Procurement Agency (hereinafter SPA) in 2019. It aims at providing the readers with thorough information with regard to the reforms implemented by the SPA in the field of public procurement, and activities performed with a view to monitor procurements, novelties introduced in the Unified Electronic System of Public Procurement – *eProcurement*¹ and various training programmes implemented with a view to increase the qualification of the procurement specialists. Along with this, the report will allow the readers to get acquainted with a number of interesting statistical data and information from the public procurement field.

In 2019 total volume of public procurements carried out with a view to procure various goods, services and construction works amounted to record number - 5,332,804,815 billion GEL, which made approximately 11% of the country's GDP and 63% of the expenditure part of the state budget.

The greatest share of the aforementioned sum - 82.4% was expended within the frames of the



contracts awarded through competitive, open e-tenders which is also the highest index from the day of introduction of Unified Electronic System of Public Procurement up to the present. Respectively, the share of the contracts awarded through simplified procurements² in overall procurements was reduced to 17.6%. The said positive index is the outcome of consecutive reforms implemented in the field of public procurement in the recent years.


In order to ensure even better value for the money, the practice of carrying out centralized, so called "consolidated tenders" were reasonably fine-tuned in 2018 as a result of the cycle of reforms initiated by the government of Georgia and SPA. Thus, by 2019 it was possible to expand the spectrum of various services and goods to be procured through consolidated tenders. In total, the contracts valued at 403 million GEL were awarded through consolidated open e-tenders carried out

in 2019 and besides savings as a result of the mentioned tenders exceeded 100 million GEL in relation to retail and wholesale prices of the respective objects of procurement.



In 2019, several already existing modules were further improved in the *eProcurement* System of Public Procurement, new functionality was integrated and technical updates were implemented enabling the users to operate in the system more easily.

In particular, user-oriented functional update applied to so-called simplified procurement CMR module of the system; new search parameters were added to a special monitoring module of the system; furthermore, a totally new module of management of contracts of consolidated tenders was added to the system.

The 25 training cycles were arranged in the SPA Training Center in 2019. Trainings were held in two different programmes – "Course in Public Procurements" and "Novelties in Public Procurements". In total 700 trainees were trained within the frames of the aforementioned training programmes.


In the future, the SPA will continue to pay particular attention to fostering transparency of procurement processes and engagement of society, as well as to expanding dialogue with civil and business society, offering new services to them, monitoring of procurement process and mitigation of all kinds of risks of corruption, development of procurement procedures and even more approximation of procurement practices to the standards established by the EU Directives through intensification of international cooperation. The SPA will continue the process of intensive training of procurement specialists with a view to further improve their skills and qualifications.



KEY DATA INDICATORS OF PUBLIC PROCUREMENT


In 2019, totally 34,216 tenders³ were announced in the eProcurement System of Public Procurement for the procurement of various goods, services and construction works (See Diagram N1 for details), which exceed the number of tenders announced in 2018 by approximately 5%⁴.

As in previous years, the most tenders in 2019 were announced in December. The high number of tenders announced in the end of the year is largely due to the need of timely and assured conduct of procurements necessary for the following year.




Table N1 and Diagram N3 below show distribution of tenders carried out in 2018 and 2019 according to estimated value. As the diagram shows, the share of tenders with high estimated value has reasonably increased as compared to 2018 and the amount of tenders with comparatively low estimated value has reduced respectively. In particular, if in 2018 the number of tenders with estimated value of 50,000 GEL and more amounted to 7,736, this figure increased up to 8,246 in 2019. The change of the said data is conditioned by more aggregation of the needs of contracting authorities.

According to the data of 2019, the total estimated value of relatively large-scale tenders has also increased. In particular, 94.1% of net estimated value of tenders announced in 2019 (4,801,948,205 GEL) falls on those 8,246 tenders whose estimated values exceed 50,000 GEL; a similar showing for 2018 amounted to 92.7% (See Table N2).

Net value of public procurement contracts awarded in 2019 exceeded 5.3 billion GEL which equals approximately 11.7% of the country's GDP. Thus, total value of contracts executed in 2019 exceeds similar showing for 2018 by 1.3 billion GEL⁷. It is noteworthy that share of values of contracts awarded through tenders amounted to approximately 4.4 billion GEL what makes 82.4% of total public procurements⁸.



Diagram N4: Volume of public procurement contracts




Value of public procurement contracts awarded with non-resident suppliers¹⁰ through tenders amounted to over 132 million GEL. In total, 61 public procurement contracts were awarded to non-resident suppliers through tenders.

In 2019, 32,571 tenders were completed and respective final statuses were assigned to them in the *eProcurement* System. Contracts were awarded with 71% of completed tenders (23,032 tenders), while contracts were not awarded, no bids were received or terminated tenders amounted 29% (9,539 tenders); see detailed data in Diagram N6.

Diagram N6: Final statuses assigned to tenders in 201912





Diagram N7: Distribution of contracts awarded in 2019 according to objects of procurement



Net estimated value of awarded tenders (23,032 tenders) in 2019, amounted to 3,963,988,455 GEL, while net value of contracts amounted to 3,609,891,394 GEL¹³. Thus, savings as a result of competition in tenders reached to 354,097,061 GEL (approximately 9% of net estimated value of tenders). Of them, most economy – up to 262 million GEL, was made in tenders for construction works. Table N3 below demonstrates savings in details, according to procurement objects.



Average number of bidders in tenders completed in 2019 amounted to 2.05. It is noteworthy to mention that the highest average number of bidders were observed in construction works tenders and the lowest – in miscellaneous services tenders (See Diagram N9).

Furthermore, reasonable difference in average number of bidders is observed in different types of tenders. In particular, average number of bidders in NAT tenders (Electronic Tender without Auction, sealed bid auction) exceeds the average number of bidders in SPA tenders (Electronic Tender with Reverse Auction, open tender) by approximately 17% (See Diagram N10).



Diagram N9: Average number of bidders according to procurement objects14





Diagram N10: Average number of bidders according to types of tenders¹⁵



During 2019, 3,273 new suppliers were registered in *eProcurement* System and total number of suppliers registered within the system exceeded 41 000.

It should be mentioned that among the suppliers registered in the system, up to 1,977 suppliers are non-resident business entities¹⁶ from 76 countries (See Diagrams N12 and N13).

Furthermore, the number of contracting authorities registered within the system has increased. In 2019, 190 new contracting authorities were added to the system and their overall number amounted to 4,442 by the end of the year.

Diagram N11: Number of suppliers registered within eProcurement System of Public Procurement according to years






Diagram N12: Number of non-resident suppliers registered within eProcurement System of Public Procurement according to countries







Diagram N13: Distribution of non-resident suppliers registered within eProcurement System of Public Procurement according to regions

Tables N5, N6 and N7 below show Top 10 contracting authorities according to net estimated value of tenders, savings through tenders and average number of bidders. As the data shows, the highest net estimated value of tenders and the highest rate of savings were recorded in tenders of the Roads Department of the Ministry of Regional Development and Infrastructure of Georgia; and the highest average number of bidders (3.55 bidders) were recorded in tenders announced by the City Hall of Khelvachauri Municipality.

PROCUREMENT WITH THE DONOR FUNDS - DEP TENDERS

In 2019, total of 108 e-tenders were announced in the Unified Electronic System of Public Procurement which were funded with the sources of different international financial institutions and donors (DEP tenders). Overall estimated value of the DEP tenders amounted to 485 million GEL. The table below shows distribution of net estimated value of tenders according to donors.

IMPROVEMENTS TO LEGAL FRAMEWORK

In order to improve legal framework, to fine-tune public procurement procedures and fulfill international obligations, in 2019 a number of amendments were made to legal framework regulating public procurement. In particular:

- 1. Order N3 of August 21, 2019 "On Approval of the Procedures and Terms of Application of Monetary Thresholds Established by the EU Directives in the Field of Public Procurement" was issued by the Chairman of the State Procurement Agency. The order introduced monetary thresholds established by the EU Directives in the field of public procurements. According to the new regulations, if value of the tender for homogenous goods, services and works equals or exceeds the aforementioned monetary thresholds, a contracting authority shall announce tender notice for no less than 30 days, out of the 30 days, 25 days are designated for getting acquainted with tender notice and documentation, and 5 days are defined for submitting a tender. With a view to ensure the aforementioned, the SPA implemented a number of activities in order to adapt new regulations of Unified Electronic System of Public Procurement.
- 2. Order N5 of August 23, 2019 of the Chairman of the State Procurement Agency was issued, Amending Order N2 February 10, 2011 of the Chairman of the State Procurement Agency On Approval of the Rules of Reporting of Contracting Authorities. According to the amendments, contracting authorities are obliged to upload the contract of consolidated tender, also related documentation and a document reflecting modification of the contract (including cancellation of a contract) in a new module of consolidated tender, instead of CMR module. It is noteworthy to mention that the SPA ensured adaptation of Unified Electronic System of Public Procurement in compliance with the amendments thereof in such a way that contracting authorities can carry out procurements without hindrance in full compliance with the requirements of the legislation.
- 3. Order N6 of September 23, 2019, of the Chairman of the State Procurement Agency was issued, Amending annex of Order N12 of June 14, 2017, of the Chairman of the State Procurement Agency On Approval of Procedure for Carrying out e-Tender According to the amendment, e-tender on CPV45200000 can be carried out on the bases of price list only in the cases where it implies only liquidation measures for natural phenomenon and/or ongoing and/or periodic repair works of motor roads and/or artificial facilities on them and/or works to be performed in the buffer zone of the historical development area and the regulation zone of the historical development area.



PUBLIC PROCUREMENT RELATED DISPUTES


Dispute Resolution Board (hereafter DRB), which was created to ensure fair competition in public procurement, continued its operation intensively in 2019. DRB ensured impartial and grounded decisions related to disputes in the field of public procurement.

Total of 1,245 complaints were filed to the Dispute Resolution Board in 2019.

Diagram N14 shows the number of complaints filed to the Dispute Resolution Council according to years.

Resolution Board in 2011-2019




Most of the complaints filed in 2019 - 705 in total - were resolved in favor of the business sector (fully or partially granted by the Board), which made 57% of total number of submitted complaints. This fact once again proves impartiality of Dispute Resolution Board and high level of trust of business sector to the Board. Diagram N15 shows detailed distribution of the statuses of complaints.

55 out of total 1,245 complaints submitted to the Board in 2019 were withdrawn. In these cases, the complaints were withdrawn by the complainants voluntarily.

Due to the fact that all of the aforementioned complaints were dismissed in writing, the Office of the Board is familiar with the grounds for the dismissal of the complaints²² – in 49 cases the complainant did not have legal interest of reviewing the complaint any longer, 3 complaints were dismissed considering high level state and public interest; in the case of one complaint, additional consultations with various lawyers have served as the ground for its dismissal; one complaint was dismissed due to the fact that the tender ended with the status of – "No bids received" and in case of one complaint it is indicated that simultaneously two complaints have been filed, of which the complainant dismissed the one which expressed the complainant's position incompletely and besides, enclosed documents had not been submitted. 170 out of 1,245 complaints filed with the Dispute Resolution Board in 2019 were deemed ineligible due to the following grounds:



Among the claims to the Board in 2019, most of the claims relate to annulment of irrelevant decision/act of a contracting authority. Most of 1,245 filed complaints - 1,003 - concerned the decisions and acts of tender/contest commissions, while 242 complaints - tender terms and conditions (See Diagram N16).

CENTRALIZED PROCUREMENT

In 2019 a major reform was accomplished in the light of intensification and expansion of centralized procurements. To ensure efficient disbursement of budget resources, according to the Decree N446 of the Government of Georgia August 29, 2018, following procurement objects were added to be covered by centralized procurement (with total value of approximately 216 million GEL):

As a result of successful implementation of a new stage of centralized procurement reform:

- Saving of major budgetary resources were accomplished;
- **4** The risks of even theoretically possible corrupt transactions were minimized;
- ♣ The number of unjustified procurements were reduced through unification and standardization of procurement process;
- Unification and standardization of procurement process allowed monitoring of the quality of procured goods/services, monitoring process was reasonably improved;
- ♣ Procurement operations became comfortable for state institutions as well as local self-government bodies;
- ♣ The number of tenders with statuses "No bids received" or "Contract not awarded" was reduced;
- ♣ Interest of business operators, as well as level of competition was increased through aggregation of potential procurements;
- ♣ Aggregated requirements of contracting authorities were met more efficiently, at the expense of less procrastination of tender process itself;
- Level of inter-agency informational awareness and coordination was increased in the field of public procurement;
- ♣ Unified statistical database was created, which allowed efficient management of centralized procurement throughout the country.

In 2019, net initial estimated value of procurements carried out through consolidated tenders amounted to 419 million GEL, of which final value recorded in e-tendering equaled 403 million GEL; respectively, savings through e-tendering amounted to approximately 16 million GEL. It should me mentioned here that there are frequent cases when minimal prices are recorded as initial



estimated prices in consolidated tenders as a result of efficient market research and consultations rendered by the respective department of the SPA; due to this, saving through e-tendering is reduced. In such cases, the figures of savings through only e-tendering do not give an impartial picture in order to express efficiency of centralized procurements. Due to the foregoing, it is expedient to consider retail and market prices as well in order to evaluate centralized procurement reform objectively (See Table N15).

Overall savings made in 2019 through consolidated tenders with regard to wholesale and retail prices of relevant procurement objects exceeded 100 million GEL. It should be noted that this figures do not reflect savings of consolidated tenders for mobile network services, medical consumables and pharmaceutical products.

Currently, intensive analytical and research activities are underway in the SPA for the identification of additional objects, procurement of which in a consolidated manner will be justified in the light of the principle of efficient disbursement of budgetary resources or other incentives.



SIMPLIFIED PROCUREMENT

In 2019 the volume of contracts executed on the basis of simplified procurement amounted for 18% of the total procurement value, which is 1% less than similar data for 2018. Total of 5,153 applications were received in 2019 in the SPA; in 4,426 cases approval was granted, while the number of withdrawn, rejected or unconsidered applications amounted for 727. Diagrams N17 and N18 below show statistics according to the grounds and statuses of simplified procurements.

Diagram N17: Distribution of applications, filed with SMP module of the System according to their grounds





Diagram N18: Distribution of applications, filed with SMP module of the System according to their statuses





The above Diagram demonstrates, that 86% of the applications were accepted, while rejected applications account for 14% of total number of applications.

ADMINISTRATIVE INFRINGEMENTS AND COURT LITIGATIONS

In 2019, the SPA, within the scope of the powers granted to it, drew up 76 reports on administrative infringements against 205 persons. Reports on infringements submitted to the court concerned the category of infringements provided for by articles 159⁵-159⁹ of the Code of Administrative Offences of Georgia. The court has applied warnings, as administrative penalty, with regard to most of the cases on infringements, referred to the courts of law.

Overall 247 cases were reviewed by the Common Courts during 2019 with engagement of the SPA in some way. Out of these, 76 cases were on administrative offences, issued by the SPA, 87 cases referred to the Decrees issued by the Chairman of the SPA on registration in the Black List (in 2 cases the court partially satisfied claim of the complainant, that was appealed by the SPA in a superior body), 61 cases concerned decisions of the Dispute Resolution Council (the court has partially satisfied claim in 1 case), 7 cases - consolidated tenders, 21 cases concerned civil disputes on withdrawing of bank guarantee and also, contractual issues . Furthermore, 1 decree on the registration in the White List was appealed. 1 case concerned request for public information.

As already mentioned, out of 1,245 complaints filed with Dispute Resolution Council, 61 decisions of the Council were appealed to the court - these decisions make 4% of overall number of filed complaints.

Also, in 2019, 87 decrees issued by the SPA Chairman with regard to the Black List were appealed.


During 2019, Legal Department of the SPA rendered a number of phone consultations on legal issues, as well as separate issues regarding court litigations.



MAINTENANCE OF THE WHITE LIST

In 2019 total number of decisions on registering economic operators in the register of qualified suppliers participating in procurements - the so-called "White List", amounted to 192 (in 2018, 127 decisions were taken). In total 126 decisions were made by the SPA with regard to registration in the White List and extension of the registration (99 registrations in 2018), 2 economic operators were refused to be Whitelisted (3 decisions in 2018), while 64 cases were unconsidered (25 decisions in 2018). The detailed results are shown in Diagram N19.

Diagram N19: Distribution of decisions made in 2019 with regard to White List, according to their statuses






MAINTENANCE OF THE BLACK LIST

In compliance with current legislation, the SPA also maintains the register of dishonest suppliers - the so-called Black List.

In total 807 applications were filed to the SPA regarding registration of the suppliers in the Black List (607 applications in 2018). In 592 cases the suppliers were registered in the Black List by the SPA (403 cases in 2018), 138 suppliers were given the warning (143 – in 2018). The detailed results of the decisions are given on Diagram N20.

MONITORING OF PUBLIC PROCUREMENT PROCEDURES

Every year, the SPA monitors e-tenders conducted through electronic public procurement procedures, annual plans and simplified procurements.

During 2019, based on automated system of messaging and via risk methodology system, monitoring department has monitored pre-selected 13,414 tenders with status of "contract awarded" (14814 in 2018) and tenders with status of "terminated", "failed" and "not awarded" total of 1678 (639 in 2018).

Furthermore, 8,067 e-tenders (8,400 – in 2018) were monitored within the System in order to establishing the adequacy of disqualification of bidders.

The SPA is also monitoring contracts awarded through contests and simplified procurement, based on the information uploaded in the CMR module. In total 70 contracts (60 - in 2018) awarded through contests and 74,307 contracts (52,688 - in 2018) awarded through simplified procurement were monitored.

Based on the findings of the monitoring process, 1,810 letters (1,815 – in 2018) were sent to contracting authorities with regard to revealed violations. In 79 cases the reports on administrative infringement were drawn up (116 – in 2018) and in other cases the SPA limited itself to written recommendations.



DIDACTIC ACTIVITIES

Training center of the SPA, which was established in 2014, is still actively and efficiently continues its operation.

Only in 2019, 25 series of trainings were arranged and in total 700 trainees were trained in the SPA Training Center. 10 series of trainings were dedicated to the courses in public procurement within the frames of which 391 procurements specialists of state institutions and subordinated state agencies, legal entities under public law and public LLC's, also procurement specialists of municipalities and their subordinated legal entities under private law (Non-entrepreneurial, non-commercial) Legal Entities, LLCs, etc.) were trained.


15 series of trainings were dedicated to a one-day special course – Novelties in Public Procurement, within the frames of which total of 309 trainees were retrained. This training was dedicated to already certified procurement specialists and it covers all the novelties introduced to the public procurement system permanently.



In 2019 the Training Center was intensively cooperating with international and local organizations. They, in the capacity of donors and partners, greatly contributed to the organization and arrangement of joint events, trainings and workshops, as well as to acquisition and drafting of necessary literature and manuals for didactic activities of the Training Center.

From October 2014 up to present, total of 3,037 procurement specialists, experts or managers were trained and certified at the SPA Training Center. amongst them: 1,681 trainees are from the state agencies of central government, 1,286 – from local self-governing bodies and subordinated legal entities and 70 – from business sector. These figures do not include the trainees invited to international meetings, round tables, workshops and various informational-consultancy educational meetings - their overall number amounted to 358. Also, one-day training courses were taken by 678 trainees and 117 trainees from Municipality City Halls. In total, the SPA Training Centre retrained 4,190 trainees from October 2014 till December 2019.



BUSINESS COMMUNICATION WITH THE CUSTOMERS

In 2019 the document flow (number of incoming and outgoing letters) of the SPA amounted to 14,446 (in 2018 this figure made 15,713). Also 7,697 (6,024 in 2018) e-mail letters were received and addressed at the SPA official e-mail (<u>info@procurement.gov.ge</u>). Total 1,585 letters were archived in 2019 (2,195 in 2018).

Each and every interested person is entitled to get exhaustive and competent answer via SPA citizen hotline service - (+99532)2484822. In total 20,298 calls were received and answered by the SPA citizen's hotline service in 2019 (17,781 in 2018).

Short Messaging Service (SMS) and system notices, integrated into the *eProcurement* System, also web portal - spa.ge, keep persons interested in public procurement constantly updated about the amendments, notices, introduction of new regulations and development of new services. They can also receive timely and exhaustive information about tenders they are interested in. Only in 2019 approximately 48 million system notices and over 251 thousand SMSs were circulated.

2019 was very rich and efficient for the State Procurement Agency in the light of international relations. A number of meetings, conferences or events were held. In particular:

- Officials of the State Procurement Agency held a meeting with the council members of Georgian Chamber of Commerce and Industry (GCCI). The meeting was organized by the Georgian Chamber of Commerce and Industry. At the meeting, the Council members of the GCCI expressed interest over the challenges in regard to the foregoing issue. The parties of the discussion also raised the issue with regard to appealing consolidated tenders in the Dispute Resolution Council;
- In 2019 a Steering Committee Meeting of the EU Twinning Project (Instrument for Institutional Cooperation of Public Administrations) "Strengthening Public Procurement Practices in Georgia" was held. The project is fully funded by the EU and is being implemented by the Austrian Federal Procurement Agency and Slovenian National Public Procurement Review Body. The project mainly aims at further development and modernization of Georgian public procurement practices in compliance with European and international standards, which, in its turn, implies establishment of efficient, transparent, non-discriminative and competitive public procurement eco-system in the country. The representatives of the SPA and Ministry of Foreign Affairs of Georgia, Delegation of the European Union to Georgia, also high officials of the Austrian Federal Procurement Agency and Slovenian National Public Procurement Review Body were participating in the meeting;

Within the frames of the project, SPA has organized an event, where audience were addressed by Maia Tskitishvili, Vice Prime Minister of Georgia, Levan Razmadze, the Chairman of the State Procurement Agency, Nino Chikovani, President of Georgian Chamber of Commerce and Industry. The event was attended by the representatives of the Ministry of Foreign Affairs of Georgia, Ministry of Finances of Georgia, Ministry of Economy and Sustainable Development of Georgia and other ministries, also, representatives of the Delegation of the European Union to Georgia, Embassy of Austria to Georgia, Consulate of Slovenia in Georgia, international and donor organizations, business society representatives, civil sector and other interested parties;





• A media event, organized by the SPA and EU Twinning Project was held. The staff of the SPA provided journalists with the information in regard to regulations, procedures and rules in the field of public procurement. European experts made presentations. The meeting was held in a Q&A format;





• Within the frames of EU Twinning Project "Strengthening Public Procurement Practices in Georgia", special two-day training, outside of Tbilisi was arranged for Georgian lawyers. SPA trainers delivered training on ongoing and planned novelties in Georgian public procurements to the judges. The meeting was held in a Q&A format. The foregoing study visit aimed at sharing the best EU practice with Georgian counterparts from judiciary with regard to ongoing legislative reforms in the field of public procurement, established new approaches and also in the light of dispute resolution procedures. Miro Prek, a Slovenian



Judge in the Court of Justice of the European Union and Karin Schnabl, Judge of Federal Administrative Court of Austria were among invited speakers. The representatives of Supreme Court of Georgia, Appeal Courts of Tbilisi and Kutaisi and Tbilisi City Court participated in the study visit;



- An event related to mitigation of risks of corruption in the field of public procurement was arranged. The event was held within the frames of EU Twinning Project "Strengthening Public Procurement Practices in Georgia" and it aimed at sharing information to interested Georgian audience by the representatives of EU member states in regard to the best international or European practices and mechanisms for prevention and eradication of corruption in the field of public procurement. The event was facilitated by high ranked EU experts and the Chairman of the SPA, Levan Razmadze; representatives of various public institutions took part in the workshop;
- In 2019 an international Workshop on Public Procurement in Utility Sector was held. According to the road map of the reforms adopted within the frames of Deep and Comprehensive Free Trade Agreement (DCFTA), that implies gradual approximation to the EU legislation, approximation to the European Council's Utilities Sector (energy, gas, water, transport, postal, ports and airports services) Directive (2014/25/EU) is stipulated in the coming years. The aforementioned Directive provides for a number of legislative amendments and new regulations with a view to improve services in utilities sector. High rank experts of EU member states facilitated the meeting and they presented to the audience



the principles and provisions of European Council's Utilities Sector Directive; also, they discussed the issue of harmonization of Georgian legislation with the foregoing regulations.





INTENSIFICATION OF INTERNATIONAL RELATIONS

The year of 2019 was rather productive for the State Procurement Agency in the light of intensification of international relations:

- The SPA actively continues fulfillment of the roadmap approved by the government of Georgia within the frames of Deep and Comprehensive Free Trade Agreement (DCFTA). In December 5, 2019, the annual meeting of the Association Committee in Trade Configuration (ACTC) was held in the Ministry of Economic and Sustainable Development of Georgia. At the Committee meeting the representatives of the European Commission were presented an extended report and detailed presentation in regard to the implementation of the obligations undertaken by Georgia within the frames of DCFTA;
- In February 2019, the EU-funded EU Twinning Project was launched; Aim of the project is to provide institutional support to the SPA and share the best European practices. The project consists of three components: 1) support in improving public procurement legislation; 2) delivering trainings and fostering skills; 3) reformation of administrative dispute review body;



The State Procurement Agency, in partnership with the OECD SIGMA, has organized 3rd regional conference on public procurement for Eastern Partnership Countries in Tbilisi in November 5-8, 2019. Vise Prime Minister of Georgia Ms. Maya Tskitishvili addressed conference participants with opening speech. Representatives of public procurement



authorities of central and eastern European countries as well as representatives of EU commission (DG GROW, DG NEAR), the World Bank, ADB and other leading international organizations attended the conference.



At the conference participants exchanged with presentations and engaged in discussions on ongoing reforms in public procurement. Participants exchanged with experiences in public procurement reforms of different countries. Conference also encouraged formal and informal bilateral discussions and bilateral partnerships between public procurement authorities of different countries;









- Throughout 2019, the SPA was intensively engaged in the implementation of National Anti-Corruption Strategy and Action Plan 2019-2020, approved by the government of Georgia. In December 9, 2019, in regard to International Anti-Corruption Day, Ministry of Justice of Georgia under the assistance of the USAID GGI programme organized meetings of the representatives of SPA and other stakeholder institutions with the representatives of local self-government institutions and students of Shota Rustaveli University in Batumi. Invited guests got familiarized with the anti-corruption reforms implemented in the field of public procurement;
- In January and May 2019, negotiations were held with the government of the UK on free trade agreement between the UK and Georgia. The agreement covers the field of public procurement, and envisages gradual opening of public procurement markets of the contracting parties;;
- In April 2019, a meeting of the Georgia-Kazakhstan Intergovernmental Bilateral Commission on Trade and Economic Cooperation was held in the city of Nur-Sultan. At the meeting the parties agreed on bilateral cooperation, including field of public procurement. It should be underlined that in the memorandum of bilateral cooperation, parties expressed an intension to cooperate in the field of public procurement; The SPA is intensively engaged in the European Commission Macro-Financial Assistance (MFA) Programme, which is coordinated by the Ministry of Finance of Georgia. In 2019, several rounds of negotiations were held with the representatives of the EU on the status of the obligations undertaken within the frame of MFA. It should be mentioned that the State Procurement Agency successfully implemented MFA obligations in 2019;
- In 2019, under the inter-agency working commission, the SPA was intensively engaged in drafting process of defense and security chapter in the new public procurement law, which represents one of the obligations towards NATO partnership. Throughout 2019 several meetings were held with the Ministry of Defence and the NATO mission; as a result, a draft law on defense and security was elaborated and integrated in the new draft law on public procurement, currently being under discussion;





Delegations from Afghanistan, Uzbekistan, Tajikistan, Kazakhstan, Malaysia, India, Latvia
and Ukraine visited SPA on study mission in 2019. the delegations got familiarized with
ongoing and implemented reforms in Georgian public procurement. The guests also got
acquainted with the Unified Electronic System of Public Procurement and various
advanced innovative e-services;





New regional initiative in Eastern Partnership Countries – EU4Environment²⁴ which is Funded by the EU, was launched in 2019. The initiative aims at introduction of innovative products and technologies through encouraging green investments. One of the components of the foregoing initiative stipulates elaboration of sustainable public procurement²⁵ system, which will be an important instrument to promote energy-efficient and green economy. With regard to the aforementioned initiative, SPA has organized workshop with representatives of EU4Environment program and other stakeholder ministries in September 2019. Launch of a new project is intended in 2020 within the frames of the programme; the goal of the project is to introduce sustainable public procurement system and to boost green public procurement. Parties agreed on further steps and activities of the project;
