

Invitation for Bids – Rebidding

1. Georgia has received financing from the Asian Development Bank (ADB) toward the cost of the **Urban Services Improvement Investment Program (USIIP) – Tranche 6**, and it intends to apply part of the proceeds of this financing to payment under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **United Water Supply Company of Georgia (UWSCG)** (the Employer) invites sealed bids from eligible Bidders for the **individual contracts (lots) or for any combination of it for the Construction Works of Water Supply and Sewerage Systems in Marneuli and Sewerage System and Collector in Bolnisi in six lots**, in particular:
 - Lot 1: USIIP/T6/CW/2022/L1/MAR-01 Zone 1 (Marneuli)
 - Lot 2: USIIP/T6/CW/2022/L2/MAR-01 Zones 2, 3, 6 (Marneuli)
 - Lot 3: USIIP/T6/CW/2022/L3/MAR-01 Zones 4, 5 (Marneuli)
 - Lot 4: USIIP/T6/CW/2022/L4/MAR-01 Bolnisi City Network
 - Lot 5: USIIP/T6/CW/2022/L5/MAR-01 Interceptor
 - Lot 6: USIIP/T6/CW/2022/L6/MAR-01 Kolagiri Wellfield

The estimated duration of the activities (construction) under the contract is:

- 180 days for Lot 1
 - 365 days for Lot 2
 - 365 days for Lot 3
 - 365 days for Lot 4
 - 365 days for Lot 5
 - 540 days for Lot 6
3. **International Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Average Annual Construction Turnover: Minimum average annual turnover of:

\$ 29,100,000.00 – Lot 3
\$ 10,300,000.00 – Lot 4
\$ 11,200,000.00 – Lot 5

Calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (in case of Joint Venture: Each partner must meet 25 percent and one partner – 40 percent of the requirement).

- Financial Resources: The Bidder must demonstrate access to, or availability of liquid assets, lines of credit, or other financial resources, to meet the Bidder's financial resources requirements in the amount of:

In case of Joint Venture: Each partner must meet 25 percent and One partner – 40 percent of the requirement; and all partners combined – 100 percent of the requirement.

- Contract of Similar Size and Nature: Participation in at least one (1) contract that has been successfully or substantially completed within the last five (5) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds:

The similarity of the Bidder's participation shall be based on the physical size, nature of works and complexity.

For the above or other contracts executed during the period stipulated in 2.4.1 of the section 3 of the Bidding Documents, a minimum construction experience is required in the following key activities:

LOT 1

- Water pipe laying works, not less than 3700 m HDPE pipes. (In one year period within the last 5 years).
- Installation of metered house connections 1400 Nos. (Within the last 5 years)

LOT 2

- Water pipe laying works, not less than 32,200 m HDPE (In one year period within the last 5 years).
- Sewer pipe laying works of corrugated HDPE pipes of not less than 27,700 m (In one year period within the last 5 years).

LOT 3

- Water pipe laying works, not less than 35,500 m HDPE (In one year period within the last 5 years).
- Sewer pipe laying works of corrugated HDPE pipes of not less than 39,700 m (In one year period within the last 5 years).

LOT 4

- Sewer pipe laying works of corrugated HDPE pipes of not less than 22,000 m (In one year period within the last 5 years).

LOT 5

- Sewer pipe laying works of corrugated HDPE pipes of not less than 11,800 m (In one year period within the last 5 years).
- Installation of M&E equipment of at least one 60 KW pumping station, including standby pumps (Within the last 5 years).

LOT 6

- Construction of Reinforced concrete reservoir of 5000 cum capacity (Within the last five years)
- Installation of M&E equipment of at least one 640 KW pumping station, including standby pumps. (Within the last 5 years).
- Water pipe laying works, not less than 12,800 m DCI pipes (In one year period within the last 5 years).
