Georgia has received a loan from the Asian Development Bank (ADB) towards the cost of **the Urban Services Improvement Investment Program (USIIP) – Tranche 6.** Part of this financing will be used for payments under the contract stated above. Bidding is open to bidders from eligible source countries of ADB.

- 2. The United Water Supply Company of Georgia (UWSCG) (the Purchaser) invites sealed bids from eligible bidders for the individual contracts (lots) or for any combination of it for the supply of Special Machinery comprising following lots and goods:

- Lot 2: Procurement of 56 item 4x4 stake Body Vehicles UWSCG-ICB-L2-Machinery-2021.02 (LOT 2)
- Lot 3: Procurement of 25 item Box-type Delivery Van. UWSCG-ICB-L3-Machinery-2021.02 (LOT 3)

- International Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
- 4. The Minimum key qualification criteria include but are not limited to the following:

<u>Contractual Experience:</u> Successful completion as main supplier within the last 3 years, of at least following Contracts:

LOT 1: Upto two contracts with combined value of USD 700 000.00

LOT 2: Upto two contracts with combined value of USD 850 000.00

LOT 3: Either 1 contract valued at USD 240 000.00 or two contracts with combined value of USD 320 000.00

LOT 4: Either 1 contract valued at USD 145 000.00 or two contracts with combined value of USD 195 000.00 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

<u>Technical Experience:</u> Successful completion as main supplier within the last three (3) years of at least following Contracts and who has been in operation for a minimum of three (3) years:

8 Water Trucks.

<u>Production Capacity:</u> The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods as required by Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply).

<u>Historical Financial Performance:</u> Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last 3 (three) years to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

Average Annual Turnover: Minimum average annual turnover:

- USD 1,345,000.00 for Lot 1
- USD 1,585,000.00 for Lot 2
- USD 600,000.00 for Lot 3
- USD 365,000.00 for Lot 4
