1. The Government of Georgia has received financing from the Asian Development Bank (ADB) toward the cost of **Sustainable Water Supply and Sanitation Sector Development Program**, and it intends to apply part of the proceeds of this financing to payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The “**United Water Supply Company of Georgia**” LLC (“the Purchaser”) invites sealed bids from eligible Bidders for the individual contracts (lots) or for any combination of it for the Supply of Machinery, comprising following lots and goods:
 - LOT 4 – EQ2/LOT 4 – Procurement of 19 Backload Excavator (Large)
 - LOT 8 – EQ2/LOT 8 – Procurement of 1 Tow Trailer
 - LOT 9 – EQ2/LOT 9 – Procurement of 2 Buckets
 - LOT 10 – EQ2/LOT 10 – Procurement of 1 Warehouse Loader
3. **Open competitive bidding – International advertisement** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:¹
 - **Contractual Experience:**
Successful completion as main supplier within the last **three (3) years** of contracts:

LOT 4: Up to two contracts with combined value of USD 1,600,000.00
LOT 8 Up to two contracts with combined value of USD 60,000.00
LOT 9: Up to two contracts with combined value of USD 160,000.00
LOT 10: Up to two contracts with combined value of USD 40,000.00

¹ In case the Bidder submits the bid for 2 or more lots, requirement will be summed accordingly. The complete eligibility and qualification requirements are stipulated in the Bidding Documents.

with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

- **Technical Experience**

The Bidder shall demonstrate that the goods offered have been in production for **at least 3 years** and have been sold a minimum of:

LOT 4: 19 Backload Excavator (Large)

LOT 8: 1 Tow Trailer

LOT 9: 2 Buckets

LOT 10: 1 Warehouse Loader

of similar type and specification over the **last three (3) years**; been in operation for a minimum of **3 years**.

- **Production Capacity**

The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods as required by Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply).

- **Historical Financial Performance:**

Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last **three (3) years (Fiscal Years 2022, 2023 and 2024)** to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

- **Average Annual Turnover:**

Minimum average annual turnover calculated as total payments received by the Bidder for contracts completed or under execution over the last **three (3) years**.

Required Average Annual Turnover for each lot is as follows:

LOT 4: USD 4,000,000.00

LOT 8: USD 150,000.00

LOT 9: USD 400,000.00

LOT 10: USD 100,000.00
